

## Go-Bet Betting Rules

### 1. Terms of Acceptance

- 1.1. All bets must be paid for before the stated advertised off time.
- 1.2. The placing of a bet with Go-Bet, signifies your acceptance of our rules, whether or not you have familiarised yourself with them.
- 1.3. Subject to these rules, bets are accepted for race meetings held under the Jockey Club or their equivalent bodies abroad.
- 1.4. We reserve the right to refuse the whole or any part of any bet but will endeavour to always give an explanation.
- 1.5. All bets are deemed for the day of acceptance, unless stated otherwise.
- 1.6. We endeavour to ensure complete accuracy as regards announcing, publishing and issuing of prices, however, should an error occur, we cannot accept responsibility and reserve the right to correct obvious errors. Or in the event of systems malfunction bets placed during this time will be void
- 1.7. Withholding Payment.  
We reserve the right to withhold payment and to declare bets on an event void if we have evidence that the integrity of the event has been called into question, the price or pool has been manipulated or match rigging has taken place.
- 1.8. Fraud  
Go-Bet will withhold payment to any customer where fraud, dishonesty or criminal action is suspected.  
The customer shall indemnify and shall be liable to pay Go-Bet, on demand, all costs, charges or losses sustained or incurred by us including and direct, indirect or consequential losses, loss of profit and loss of reputation arising from the customer's fraud, dishonesty or criminal act.  
If there is evidence of a customer circumventing our Bet Acceptance procedures or Trading Restrictions by concealing their identity or using an agent to place bets or by any other method, these bets will be deemed to be void.
- 1.9. Special bets are settled in accordance with the special rules issued for such bets.
- 1.10. All bets accepted will be settled on the official result, unless otherwise stated.
- 1.11. Where a race is specified by using race card order, the race will be placed and timed as the card in the sporting press, with allowances for obvious errors.
- 1.12. We cannot guarantee to pay or correct errors, if they are brought to our attention, more than six months after the official result of the last selection to run on the bet.
- 1.13. Errors made by operator or other when placing the bet through the system must be identified at the time of placement. Customer must declare the error within 30 seconds of receiving the printed ticket.

### 2. Time of Acceptance

- 2.1. For all cash bets, the time at which the bet was recorded through our IT system and printed on the ticket, will govern settlement.
- 2.2. For online bets, bets will be deemed to be accepted when they have been registered in Go-Bet database.
- 2.3. Where the official off of a race is not announced, bets will be accepted up to the advertised off time. Any bet taken after this will be deemed void, unless we are satisfied that the bet was accepted before the actual off.
- 2.4. No bets shall be accepted in respect of a horse race once such horse race has officially started. If a bet is accepted after the off, the selection(s) will be deemed void.

### 3. Limits

- 3.1. Any stake or payout limits applicable to bets will be clearly stated by notice within the venue.
- 3.2. For multiple bets including selections from markets where different limits may apply, the maximum payout on the bet will default to the lowest applicable limit.
- 3.3. Where bets are placed on different days, the maximum payout limit where stated 'per person per day' will apply to the day that the final selection in the bets were completed and not to the day that the bets were placed.

3.4. Any group of customers who have placed the same combination of selections and we believe have been acting as a syndicate will be treated as one customer for the purpose of the above limits.

**4. Displayed Prices & Information**

- 4.1. Bets are accepted at show prices, as transmitted by the official information service to our office, e.g. SIS. Where a show price is requested, it will apply to that selection in all win and each way bets, unless it is clearly indicated otherwise.
- 4.2. Ante-post betting ceases at the final declaration stage and all bets placed after the final declaration stage will be non-runner no bet, deductions table may apply.
- 4.3. We cannot allow for mistakes, nor accept responsibility for any errors or omissions in respect of accuracy in publishing or issuing of prices or information, despite our every effort to ensure total accuracy and reserve the right to correct these errors.

**5. Dead-heats**

- 5.1. When a dead-heat occurs for first place, the stake money on the winning selection will be divided by the number of winners and full odds paid on the reduced stake. The remainder of the stake is lost.
- 5.2. Where an each way bet involves a dead-heat winner, the win part of the bet will be settled as above and the place part will be settled in full, in accordance with the relevant place terms. Should the dead-heat involve placed selections and results in more than the allocated number of places, then the stakes will be divided, as before and settled to the full place terms.

**6. Deductions**

Where a horse/contestant is withdrawn before or after coming under starter's orders, all fixed odds bets on that horse/contestant shall be void, and all bets struck as fixed odds on the remaining horses/contestants on the day of the race or "with a run" shall be subject to

6.1. deduction calculated in accordance with the following table –

Any bets struck "with a run" after the official announcement of the withdrawal of one of or more horses/contestants shall not be subject to any adjustment unless there are further withdrawals.

Should two horses/contestants be withdrawn simultaneously and both are subject to a deduction on any winning bets, the deductions shall be applied separately and not simultaneously.

Deductions shall not apply to starting price bets, unless a late withdrawal(s) occurs.

**7. Settlement of Bets**

7.1. Bets are settled on the official result as declared immediately following the event subject to any other provision in our rules. Where a result is amended after the official result is declared,

for example as a result of a successful appeal, the amendment will be ignored for settlement purposes.

- 7.2. Where bets or parts of bets are made void, stakes on singles will be refunded, but on multiple bets, the void selection will be treated as a non-runner.
- 7.3. All bets are settled strictly on their merits and no plea of precedence will be accepted.
- 7.4. We cannot guarantee to pay or correct any returns, if they have not been claimed within 90 days of the official result.
- 7.5. For the purpose of settling each way doubles, trebles etc. they are calculated as 2 distinct bets, i.e. win to win and place to place.
- 7.6. If two selections are engaged with the same name and both selections are still to run at the time of acceptance, provided that no time has been given, the bets will be settled on the runner without a suffix for the country of origin, e.g. USA, IRE.
- 7.7. In all cases of incorrect or incomplete instructions, the bet will be taken as win, unless each way is stated.
- 7.8. For horse racing, where two selections are nominated in the same market and no instructions given, and then the bet will be settled as a straight forecast or a combination forecast where three or more selections are nominated.
- 7.9. Where a win or each way bet is requested with nominated selections in the same market, the bet will be settled as singles with the stake divided equally.
- 7.10. In multiple bets, where two or more selections are in the same market, the stakes will be divided equally where the selections meet in the bet i.e. two selections in doubles and upwards, in the same race will be settled as follows: Stake single on each selection where they meet in doubles; winnings follow through to trebles and onwards and settled on the remaining selections as standard.

## 8. Ante-post

- 8.1. Ante-post prices are those offered on:
  - a. A horse race prior to the final declaration stage.
  - b. Sporting events as advertised four or more days before the scheduled start of the match or competition.
- 8.2. Ante-post bets are accepted on the basis of 'all in run or not', i.e. stakes are lost if the selection does not take part, if there was a possibility of it winning at the time the bet was laid.
- 8.3. For win and place multiple accumulator bets the place part of an each way bet, the fraction odds and number of places relating to each event, are those pertaining on the date of acceptance.
- 8.4. Place only bets and forecast bets are not accepted ante-post, unless advertised otherwise.
- 8.5. Bets are executed at the price ruling at the time of acceptance. We reserve the right to correct any obvious errors.
- 8.6. All ante-post selections will be made void if:
  - a. The race or event is abandoned.
  - b. The race or event is officially declared void.
  - c. The conditions or venue of the race or event are altered, after the bet is struck.
  - d. The race is reopened or additional runners (other than known reserves) are added.
  - e. A horse is balloted out. In this instance, the liabilities against the horses remaining are reduced at the rate in accordance with the deductions table depending on the odds currently available on the balloted out selection(s).
- 8.7. Where the same selection is backed to win two or more events in an ante-post accumulator bet, a special price will apply, irrespective of the individual odds quoted. See Related Contingencies.

## 9. Rigging

- 9.1. Where there is evidence of price, race, match or event rigging, we reserve the right to withhold payment, pending the outcome of any subsequent investigation and ultimately to declare bets on that event as void.
- 9.2. Where evidence of rigging exists or where there is evidence of a series of bets each containing the same selection(s), having been placed by or for the same individual or by a syndicate of individuals, we reserve the right to require claims for payment to be submitted in writing to our Customer Service Department.
- 9.3. In the event of an official enquiry in relation to suspicious betting activity surrounding an event, we reserve the right to disclose confidential information to the sports governing body or their representatives, on the condition that they consent to keeping such information confidential.

## 10. Related Contingencies

- 10.1. Except where advertised, multiple bets are not accepted where the outcome of one part of the bet contributes to the outcome of the other. If taken in error, the stakes will be equally divided where they clash, e.g. R10 double on Manchester United to win the match and Manchester United to win at half time and full time, would be settled as 2 x R5 singles.
- 10.2. However, where the related parts of the bet are resolved at different times, the bet will be settled as instructed, with the price for the subsequent legs being determined at each individual stage. For example; Nadal to win his semi final at 5/6 and Nadal to win the tournament outright at 9/4 would be settled as Nadal for the semi-final at 5/6 and the price for Nadal to win the final at the odds after the completion of the semi final.

## 11. Betting in Play

- 11.1. We bet 'in-running' on a selection of live events. Whilst we endeavour to ensure that the odds displayed are current, the nature of live betting means that, on occasions, these will differ by the time you confirm the bet. In the event of a system breakdown all prices are time checked to ensure you receive the correct price.
- 11.2. Any request for in-running price quotations are deemed as price requests and not a request for a bet, subsequent price changes may take place after the initial quotation of prices.

## 12. Complaints & Disputes

- 12.1. Where there is any disagreement between a customer and go-bet due to interpretation of the rules or other reason. The Western Cape Gambling and Racing Board are the ruling authority and the customer must submit a dispute to them directly.

## 13. General Sports

- 13.1. In the case of abandoned matches, or matches where the original scheduled amount of play is changed, (for example, a reduction in the number of overs in a cricket match) except where specifically stated otherwise, bets will be settled on the current result if further play could not affect that result. For example if a football match has been abandoned but the number of corners has already exceeded the maximum number specified, then further play could not affect that result.
- 13.2. Any multiple bet reduced by a void, abandoned or postponed match will stand for the remaining selections, irrespective of the minimum number of selections required.
- 13.3. Place terms on sports betting are those that were relevant at the time that the bet was placed. If you place an each way bet and you are uncertain as to the current place terms you should ask a member of staff to confirm them at the time. Place terms on horse racing, with the exception of ante-post are those that were relevant at the start of the race.
- 13.4. In the event that the number of scheduled sets/legs to be played is changed (for example a match that was originally scheduled to be played over five sets being reduced to three), then match bets will stand but set betting will be made void.
- 13.5. Unless specifically stated otherwise in our rules for each individual sport, bets on any two runner market that ends in a tie or draw, or exactly the number of points quoted, where no price was offered for that eventuality, will be made void and stakes returned. Dead-heat rules will apply for bets placed on markets with three or more runners unless stated otherwise.
- 13.6. With the exception of ante-post markets, unless specifically stated otherwise in our rules for individual sports, bets on abandoned or postponed matches or races, will be made void

unless rescheduled for the next day. Bets on postponed events or tournaments, such as a bet on a golfer or tennis player to win a tournament will stand for one full week from the original scheduled start date, after which time they will be made void. Bets on ante-post markets will stand until the event is completed or officially cancelled.

- 13.7. Set, frame and leg markets: The full number of sets/frames/legs required to win the match must be achieved. If circumstances, for whatever reason, prevail so the match is awarded to a contestant before this is achieved, then set/frame and leg betting on that match will be made void.
- 13.8. Handicaps: The handicap is added to the team after the final result.
- 13.9. In the event of a change of opponent from the one advertised, then all bets are void.
- 13.10. Unless stated otherwise, if a match changes to a neutral or alternate venue all bets on that match placed for the previous venue will be void. If we issue new prices for the game being played at the neutral ground, then it is the backers' responsibility to be aware of this.
- 13.11. We reserve the right to refuse the whole or part of any bet and to make ambiguous bets void.
- 13.12. We reserve the right to suspend any or all betting on a market at any time without notice.
- 13.13. In-running match betting: If a match is not completed all bets will be void unless further play could not affect the result.

#### 14. American Football

- 14.1. Overtime counts in all markets without exception.
- 14.2. Where odds for both match and handicap betting are advertised, unless the handicap or a qualifying price has been requested, all bets will be settled on the match win. However, where only handicap betting is available, bets will be settled at the published handicap whether requested or not.
- 14.3. For player match up bets, all the quoted players must compete in at least one down for bets to have action.
- 14.4. If the outcome of a two runner event is a tie, draw or exactly the number of quoted points and no price is offered for this outcome, then the result is a push. When this occurs, the settlement of single bets is to return stakes and for multiple bets the selection is treated as a non-runner and the bet will be settled on the remaining selections.
- 14.5. Grand Salami: This is a bet on the number of points to be scored in a specified number of the days matches. For bets to have action all games must complete in full, otherwise bet will be made void.
- 14.6. Bets on first touchdown scorer are all in play or not.
- 14.7. For match half and quarter betting, the entire match half or quarter must complete in full for bets to have action.
- 14.8. The game must be completed in full for all props, total points and special markets to have action. If the game is not completed in full then bets will be deemed to have no action and stakes refunded unless further play could not affect the result.
- 14.9. First offensive play: If the quarterback is sacked on the first offensive play of the game this is deemed to be a passing play.

#### 15. Athletics

- 15.1. Race & outright betting: Unless stated otherwise, these markets include others on request.
- 15.2. In the event of a disqualification, the medals ceremony will count as the weigh-in and determine settlement of bets. In the absence of a medals ceremony bets will be settled on the official I.A.A.F. result (or similar governing body) immediately following the race.
- 15.3. Group betting: In limited group betting in the event of any non-runner within that group all bets will be void.

#### 16. Baseball

- 16.1. Extra innings if played will count in all markets without exception.
- 16.2. Where odds for both match and handicap betting are advertised, unless the handicap or a qualifying price has been requested, all bets will be settled on the match win. However, where only handicap betting is available, bets will be settled at the published handicap whether requested or not.
- 16.3. Listed pitchers: If baseball betting is offered on the basis of both listed pitchers starting the game, then both pitchers must start the game and throw at least one pitch for bets to have

action. If either pitcher fails to start the game for any reason, the bet will be deemed to have no action and the stakes will be returned.

- 16.4.** Side & prop betting: If a game is called or suspended, winners and losers for betting are official after at least five innings of play or four and a half innings if the home team is winning. If a game is called or suspended, the winner is determined by the score after the last full inning. (Unless the home team scores to tie, or takes the lead in the bottom half on the inning, in which case the winner is determined by the score at the time that the game is called.) Stakes will be refunded if the home team ties the game and it is then suspended.
- 16.5.** Totals betting: When betting on total runs (over/under), the game must go to nine innings (eight and a half if the home team is ahead) unless the result is already determined.
- 16.6.** Run line betting: When betting on run lines, the game must go to nine innings (eight and a half if the home team is ahead) to have action.
- 16.7.** For player match up bets, all the quoted players must compete in the game for bets to have action.
- 16.8.** If the outcome of a two runner event is a tie, draw or exactly the number of quoted points and no price is offered for this outcome, then the result is a push. When this occurs, the settlement of single bets is to return stakes and for multiple bets the selection is treated as a non-runner and the bet will be settled on the remaining selections.
- 16.9.** Grand Salami: This is a bet on the number of runs to be scored in a specified number of the days matches. All games must go the full nine innings (eight and a half if home team is winning) for bets to have action. If a match is postponed for any reason the bets will be deemed to have no action and stakes will be refunded.
- 16.10.** Innings runs betting: The full inning must be completed for bets to stand unless further play could not affect the result.

## **17. Basketball**

- 17.1.** Overtime counts in all markets without exception.
- 17.2.** Where odds for both outright and handicap betting are advertised, unless the handicap or a qualifying price has been requested, all bets will be settled on an outright win. However, where only handicap betting is available, bets will be settled at the published handicap whether requested or not.
- 17.3.** For player match up bets, all the quoted players must compete in the game for bets to have action.
- 17.4.** If the outcome of a two runner event is a tie, draw or exactly the number of quoted points and no price is offered for this outcome, then the result is a push. When this occurs, the settlement of single bets is to return stakes and for multiple bets the selection is treated as a non-runner and the bet will be settled on the remaining selections.
- 17.5.** Grand Salami: This is a bet on the number of points to be scored in a specified number of the days matches. For bets to have action all games must complete in full, otherwise bets will be made void.
- 17.6.** Winning margin betting is from scratch.
- 17.7.** For match half and quarter betting, the entire match half or quarter must be completed in full for bets to have action.
- 17.8.** The game must be completed in full for all props, total points and special markets to have action. If the game is not completed in full then bets will be deemed to have no action and stakes refunded unless further play could not affect the result.

## **18. Bowls**

- 18.1.** Outright betting: All in compete or not.
- 18.2.** In the event of a match being awarded to a player before the full number of sets being played, then match bets will stand on the official winner, so long as one end has been completed.
- 18.3.** Set/handicap/special betting: The full number of sets required to win the match must be achieved. If circumstances, for whatever reason prevail, so that the match is awarded to a contestant before this is achieved, the set/handicap/special bets on the match will be void, unless further play could not affect the result.

## **19. Boxing**

- 19.1. Outright betting: In the event of a postponed fight, bets placed will be made void unless the fight is re arranged for the following day.
- 19.2. A price will be offered for the draw and in the event of this occurring; all bets on either boxer to win will be losers. If the verdict is a technical draw the result will be deemed as a draw.
- 19.3. A knockout includes a technical knockout and a disqualification.
- 19.4. Round by round betting: If, for any reason, a points decision is awarded before the full number of rounds are completed, bets will be settled on the round in which the fight was stopped. Bets which nominated to win on points will only be deemed winners if the full number of rounds are completed.
- 19.5. If a boxer fails to answer the bell, the fight will be deemed to have ended in the previous round, irrespective of what the official decision may be.
- 19.6. If, for any reason the selected number of rounds on which we are betting is changed, all round by round betting will be void, but match bets will stand.
- 19.7. Bets will be settled on the official result immediately following the fight. Announcements or enquiries after this result will not affect settlement.

## 20. Cricket

### Limited Overs Matches

- 20.1. The winner of the match will be the team advancing to the next round according to the official competition rules or awarded the trophy, with the exception of a bowl out or coin toss, in which case bets will be void. In the event of a tie and no winner being determined by the competition rules, if no price was offered for the tie, then match bets will be settled as a dead-heat.
- 20.2. Matches affected by adverse weather will be governed by the official competition rules, with the exception of a bowl out or coin toss in which case bets will be void. In the event that the official competition rules do not determine a winner, then match bets will be made void. If a match is abandoned due to outside interference, we reserve the right to void bets.
- 20.3. Top batsman/bowler markets: Excluding head to head markets. In the event that a player is not in the starting eleven, then bets on that player will be void and a Deduction may apply. Players in the starting eleven but who do not bat or bowl will be deemed losers. A minimum of 50% of the scheduled number of overs when the bet was struck, must be played for these bets to stand, unless the innings has reached its natural conclusion. Dead-heat rules apply.
- 20.4. Runs & wicket markets within an innings or match: Unless stated otherwise, at least 90% of the full number of scheduled overs at the time the bet was struck must be bowled in order for bets on runs and wicket markets to stand, except where the innings has reached its natural conclusion.
- 20.5. Runs/wicket markets in a specified number of overs: For example, first 15 overs. The full number of specified overs must be played for bets to stand, unless the innings has reached its natural conclusion or further play cannot affect the result. Any change in fielding restrictions due to a reduction in scheduled innings overs will not affect the settlement of this market. This rule also applies to first 15 overs handicap markets.
- 20.6. Sixes/extras markets: For bets to stand, both teams must bat for at least 90% of the scheduled number of overs at the time the bet was struck, unless each innings reaches its natural conclusion or where further play cannot affect the result.
- 20.7. Match handicaps: Handicaps may be quoted where one team is weaker than the other. The handicap is given in the form of runs or wickets. The handicap is added at the end of the match. If the team receiving the start wins the match, then they also are the winners of the handicap market. If the team receiving the start bats first then the handicap is translated into wickets, if they bat second then the handicap is translated into runs. Bets will always be settled on the official match result, including weather affected games or where the Duckworth/Lewis method has been applied.

### Test Matches & County Championship Matches

- 20.8. In matches affected by adverse weather, bets will stand on the official result, provided at least one ball has been bowled. In the event of a tie, bets will be settled as a dead-heat between the two competing teams and the draw will be a losing bet. If a match is abandoned due to outside interference, we reserve the right to void bets.

- 20.9. If a price is not offered for the draw, and the match finishes as a draw, all bets on the match result will be void. If the match finishes in a tie, the bets will be settled as a dead-heat between the two sides.
- 20.10. All bets relating to an innings will be void if fewer than 50 overs are completed due to external factors, e.g. bad weather. If the natural length of the innings is less than 50 overs then bets will stand.
- 20.11. Sessions runs markets will be settled on the aggregate total of both teams if both teams bat during that session. The sessions are referred to by numbers with 1 referring to the morning session of play (before lunch), 2, the afternoon session of play (between lunch and tea) and 3, the evening session of play, (play between tea and end of play). A minimum of 20 overs must be bowled for session runs to stand, unless further play cannot affect the result.
- 20.12. Unless stated otherwise, bets referring to batsman or bowlers markets are for the first innings only.

#### **Series, Competition & Tournament Betting**

- 20.13. Tournament/series outright: Bets will be settled on the official tournament result, i.e. the team to lift the trophy. If the format or participants of a tournament change, then we reserve the right to void all bets. If the designated number of matches in a two team series changes, bets on the outright market will be made void, unless further play could not affect the result.
- 20.14. Correct score betting: If the designated number of matches to be played in the series is changed, then bets will be made void.
- 20.15. Top series/competition/ tournament batsman/wicket-taker: Markets will be settled on the official competition results. Ante-post and dead-heat rules apply.
- 20.16. Batsman/bowler match bets: Markets will be settled on the official competition results. Any player not named in at least one starting XI will be deemed a non-runner and the market voided.
- 20.17. Bets placed on the same team to win more than one competition may be subject to a reducing of the multiple odds.

#### **General Cricket Rules**

- 20.18. Top batsman/batsman group: A player will be deemed a runner if named in the starting 11. Non-runner no bet, deductions may apply. Dead-heat rules apply.
- 20.19. Top bowler/bowler group: A player will be deemed a runner if named in the starting 11. Non-runner no bet, deductions may apply. Dead-heat rules apply.
- 20.20. Top batsman/bowler match bets: Any player not named in the starting 11 will be deemed a non-runner and the market voided.
- 20.21. Batsman total runs: This market will stand providing that the batsman has reached the crease. Should an innings be shortened due to bad weather or a declaration, or if a player retires hurt, his score at the end of the innings shall determine settlement of bets.
- 20.22. Score at fall of wicket: Bets will be settled on the score at which said wicket falls, regardless of any retirements. Should the wicket not fall, all bets on the market shall be made void.
- 20.23. Next man out: Unless we offer a price on neither, bets on the next man out will be void if neither player is out. If a player retires, bets will be made void.
- 20.24. Highest opening partnerships: Bets will stand as long as both opening partnerships are completed, or a result has been determined. The opening partnership is the score at the fall of the first wicket.
- 20.25. An innings is deemed to have reached its natural conclusion if the team is all out, has declared, or has won the match.
- 20.26. Speciality bets: Some of our speciality bets are wide ranging and it is not possible to list rules to cover all eventualities. However, we will endeavour to advertise obvious rules along with the betting proposition on our internet and text services. Speciality bets will be settled on the current result if further play could not affect that result. For example in a runs market, if the highest band of runs has already been exceeded, then further play could not affect that result.

### **21. Cycling**

- 21.1. Individual stage & outright betting: All in compete or not.
- 21.2. In the event of a disqualification, the podium presentation will count as the weigh-in.

**21.3.** Selected limited group betting: In the event of a non-runner all bets within that group are void.

## **22. Darts**

**22.1.** Outright betting: All in compete or not.

**22.2.** Set/leg/handicap/special betting: The full number of sets/legs required to win the match must be achieved. If circumstances, for whatever reason prevail, so that the match is awarded to a contestant before this is achieved, the set/leg/handicap/special bets on the match will be void, unless further play could not affect the result.

**22.3.** Match betting: As long as at least one leg has been completed all match bets will stand on the official result.

## **23. Football**

### **Settlement of Bets**

**23.1.** Unless otherwise stated, all markets on football matches will be for 90 minutes scheduled play, including any added injury or stoppage time. In the event of a match being abandoned before the final whistle, only bets that can be settled at the time of abandonment will stand. All other bets will be deemed void.

**23.2.** Match prices: Singles and upwards are accepted on all matches.

**23.3.** Where outright prices are offered for a match, it will signify the price for a team to progress to the next round of the competition or to lift the trophy and will include any extra time and penalty shoot outs. Where both match prices and outright prices are offered on a match, it will be assumed that bets will be for match prices, unless to win outright or a qualifying price are specifically asked for.

**23.4.** Bets will be accepted up to actual kick off time, if a bet is inadvertently accepted which includes a match after its kick off time, the match will be treated as a non-runner.

### **Goalscorer Markets**

**23.5.** Settlement of "first or last player to score" bets shall be based on the goal scorer credited with the goal..

**23.6.** First/last goalscorer: A price will be offered for no goalscorer in the match. Own goals do not count and in the event of the first goal being an own goal, the next goalscorer will be deemed the first goalscorer. Players taking no part in the match will be void. For first goalscorer, players taking no part in the match before the first goal is scored will be void. Every effort is made to quote all players for a team, however, if the first/last goal is scored by a player not quoted in the original list, that player will still count as the winner. For last goalscorer bets, any player taking part in the match will be deemed a runner whether on the pitch at the time of the last goal or not.

**23.7.** Anytime goalscorer: This bet involves predicting whether a particular player or specified team will score a goal at anytime during a match. Bets will stand until the final whistle and not include any extra time played. If for any reason a match is abandoned before the final whistle, stakes will be refunded irrespective of whether the nominated player has scored or not. Own goals do not count. Multiple bets involving anytime scorers in the same match are accepted. For anytime scorer bets, any player taking part in the match will be deemed a runner.

**23.8.** Scorecast: This bet involves predicting who will score the first goal and what the score will be in a double. Given that the two components of this double are related, the scorecast is offered at specified, discounted odds. In the event of the nominated scorer not having entered the field of play prior to the first goal being scored, the stake is automatically placed as a single on the correct score. Own goals do not count and in the event of the first/last goal being an own goal then the scorecast will be settled on the correct score coupled with the next goalscorer. If there is only an own goal in the match, then the bet will be settled as a single on the correct score.

**23.9.** Shirt numbers: This bet involves predicting whether the total shirt numbers of goalscorers in the match are under, between or over a stipulated middle band. Own goals count. In the event of a disputed goalscorer, settlement will be based upon the declared result of the Press Association immediately following the end of the match.

**23.10.** Where no teams are stated for correct score bets, then the left hand score will be deemed to be for the home team and the right hand score for the away team. For scorecast bets, this convention will stand even if the first goalscorer is for the away team.

**23.11.** Correct score: We will list as many correct score possibilities as we deem necessary. If the final correct score was not quoted in the original list, then the correct score will still count as the winner.

#### **Speciality Markets**

**23.12.** Corners: A corners bet involves predicting whether the match will produce under, exactly or over the stipulated number of corners. Only corners taken will count, corners that have been awarded but not taken will not count.

**23.13.** First corner: A first corner bet involves predicting which team will take the first corner of the match. If no corners are taken in the match, all bets will be deemed void.

**23.14.** Bookings: This bet involves predicting whether the total booking points in the match are under, between or over a stipulated middle band. Points are allocated as follows: 10 points are awarded for a yellow card, 25 points are awarded for a red card. The maximum make-up for any player is 35 points in the match (two yellows and therefore a red). The bookings of players not taking part in the game, bookings of management staff, and any bookings after the full time whistle has been blown do not count for the purposes of this bet.

**23.15.** Next card betting: Prices may be offered on the team to receive the next card, (either yellow or red). In the event that players from both teams are booked for the same incident, the team whose player is first shown the card by the referee will be deemed the winner.

**23.16.** Goals x corners: This bet involves predicting whether the total goals in the match multiplied by the total corners in the match are under, between or over a stipulated middle band

**23.17.** Time definition: When referring to 45 minutes we refer to half time. When we refer to 90 minutes we refer to full time. This includes any added injury or stoppage time played but not extra time. If a goal is scored at 27:00 for example this would be settled as 27th minute or before. If the goal is scored at 27:01 then this is the 28th minute and the market would be settled as after 27th minute.

**23.18.** Match handicap: A specified number of goals is given as a handicap to one of the teams. This number is added to the number of goals that the team has scored at the end of the match. This bet involves predicting which team will win the match after the handicap has been added to the final result.

**23.19.** Total goals: This bet involves predicting whether a specified group of matches produces under, between or over a stipulated middle band of goals. If any match is postponed or abandoned, then 2.5 goals are awarded for that match. If more than one third of the matches in the group are postponed or abandoned then all bets will be deemed void.

**23.20.** Team to win by most: This bet involves predicting which team will win by most goals. Both teams must win their respective matches or all bets are losers. Goal difference counts, e.g. 2-0 beats 2-1; but 1-0 and 2-1 is a tie.

**23.21.** Team to win both halves: To win this bet the nominated team must score more goals than the opposing team in both halves of the match.

**23.22.** How will the match be won: If the match has the prospect of extra time, golden or silver goal and a penalty shoot-out, this bet may be offered. It involves predicting which team will win and whether that team will win in normal time, extra time golden or silver goals or on penalties.

**23.23.** Penalty shoot-outs: Bets taken on the number of penalties refer to all the penalties taken. If ten penalties are not required to complete the match, bets will stand. If more than ten are taken all penalties count for settling purposes.

**23.24.** In-running betting: A number of markets are available during live televised matches. Prices fluctuate quickly and the prices displayed on the internet are a guide and may well be different at the time of placing a bet. At crucial moments, e.g. a penalty being awarded or a sending off, prices may be temporarily suspended. Various second half speciality markets are available at half time which relate to the second half of the match only.

**23.25.** Team to score next goal: Own goals count and the winner will be the team accredited with the goal.

#### **Asian Handicaps**

- 23.26.** An asian handicap is a market where a handicap is applied to the match in order to make the prices more equal. The handicap line varies from scratch, (0, also called level ball) up to any number of goals in order to balance the odds and give each of the two teams a relatively similar price. The handicap line increases from scratch in quarter goals or quarter balls, expressed as (+) or (-)  $\frac{1}{4}$ ,  $\frac{1}{2}$ ,  $\frac{3}{4}$ , 1,  $1\frac{1}{4}$ ,  $1\frac{1}{2}$  etc. to reflect the expected superiority of one team over the other.
- 23.27.** The favourite in a match will have a negative handicap represented with a (-) symbol and will have to win by more goals than the handicap in order to be a winner. The outsider in the match will receive a positive handicap represented with a (+) symbol which will be added to the final score.
- 23.28.** Whole ball & half ball handicaps: The handicap is applied to the final result of the match and the team with the most goals after the handicap has been applied will be the winner. If the number of goals for each team are level after the handicap has been applied, it will result in a push with the stake being returned.
- 23.29.** Split ball handicaps: A split ball handicap is where the level of favouritism is between a half ball and a whole ball. The handicap is presented as 0 :  $\frac{1}{4}$ . In this instance, your stake is being split equally between the whole ball and half ball handicaps. For example: Arsenal 0 :  $\frac{1}{4}$  Newcastle. If you place a £100 bet on Newcastle + $\frac{1}{4}$  you actually have two bets split as follows, £50 Newcastle +0 goal and £50 Newcastle + $\frac{1}{2}$  goal. If the match finishes as a 0-0 draw, then after applying the handicap the scores would be as follows; Newcastle +0 would result in Arsenal 0-0 Newcastle, your £50 part of the bet on Newcastle +0 would be a push and the stake returned to you. Newcastle + $\frac{1}{2}$  would result in Arsenal 0- $\frac{1}{2}$  Newcastle, your £50 part of the bet on Newcastle + $\frac{1}{2}$  would be a winner.
- 23.30.** Divisional & Long Term Bets
- 23.30.** Divisional betting: In the event of a play-off taking place to determine the outright winner of a division, we will settle on the team that are declared the official league winner by that country's football governing body. Points deductions or penalties incurred by clubs after the end of the season will not count.
- 23.31.** Divisional relegation: The prices are for the team to finish or not to finish in the stipulated number of relegation places at the start of the season. If a team is demoted for any reason other than finishing in one of these positions, bets on that selection will be deemed losers.
- 23.32.** Season match bets: The final league positions will determine the winners of all season match bets. If a team does not complete all its scheduled fixtures throughout the season, all match bets and team total points bets will be made void. Multiple bets are permitted.
- 23.33.** Season group bets: The final league positions will determine the winners of all season group bets. Multiple bets are permitted.
- 23.34.** Divisional finishing positions: This bet involves predicting whether a team will finish above, exactly in or below a stipulated position in the league. Multiple bets involving teams from the same division are not permitted, and will be voided if accepted in error.
- 23.35.** Divisional expected points: This bet involves predicting whether a team's total points for the season are under, between or over a stipulated middle band of points. These bets are restricted to singles on teams within the same division.
- 23.36.** Divisional sack race: This bet involves predicting whether a manager will not be in his position with that club when they play their last game of the regular season. The end of the regular season means the completion of the number of scheduled league matches and will include any play-off matches.
- 23.37.** P.F.A. player of the year: This bet involves predicting the player to be declared player of the year as judged by the Professional Footballers Association.

#### **Related Bets**

- 23.38.** Clearly numerous markets that we offer are related, e.g. unders/overs and shirt numbers. A full list of related bets would be onerous. However, it should be noted that such bets are not permitted. Any bets accepted in error will have the stake split equally between the related selections for settlement purposes.

## **24. Golf**

- 24.1.** Outright betting: Non-starter – no bet. Deductions may apply. If a player tees off, then that player will count as a runner. If that player subsequently retires he will be settled as a loser. Play-offs will determine win bets. Each way bets – dead-heat rules may apply.
- 24.2.** Should a tournament be affected by adverse weather or shortened for any reason the official result will govern settlement irrespective of the number of rounds completed.
- 24.3.** If a bet is struck and there is no further play, or further play does not count for the official result, those bets will be made void.
- 24.4.** Tournament match bets: A price will be offered for the tie and in the event of a tie, bets on either player to win will be lost. Play-offs will count for settlement purposes, should one player win the event. If one player misses the cut, the other is deemed the winner. If both players miss the cut, then the one with the lowest score will be deemed the winner. If a player is disqualified, either prior to the completion of two rounds or after both players have made the cut, the other player is deemed the winner. If a player is disqualified after making the cut, when his opponent has already missed the cut, the disqualified player is deemed the winner. If a player withdraws or is disqualified, either prior to the completion of two rounds or after both players have made the cut, the other player is deemed the winner. If a player withdraws or is disqualified after making the cut, when his opponent has already missed the cut, the player that has withdrawn or is disqualified is deemed the winner.
- 24.5.** Top nationality: Non-player – no bet. Deduction may apply. Play-offs will determine win bets, dead-heat rules will apply for win and place bets.
- 24.6.** Tournament group bets: Non-player – no bet. Deductions may apply. Play-offs do apply. Dead-heat rules will apply. Bets are settled on the player who achieves the highest placing at the end of the tournament.
- 24.7.** In the event of the actual 2 ball, 3 ball, or group being different from those advertised by us, bets will stand on the finishing positions of our original groupings.
- 24.8.** 18 hole, 3 ball betting: If a player does not start the round, then the 3 ball will be void. Dead-heat rules will apply. Once all players have started the round they are deemed runners.
- 24.9.** 18 hole, 2 ball betting: A price will be offered for the tie. Once both players have started the round they are deemed runners. If a player withdraws during the round his/her opponent will be deemed the winner as long as they complete the round in full.
- 24.10.** In a two runner event, if the price for the tie exists and the result is a tie, bets on both players are losers. Where no price is offered for the tie and the tie is the result all bets will be void.
- 24.11.** In a team competition, e.g. Ryder Cup, if a match is not completed and the players agree to stop playing, bets will be settled on the official result declared by the competitions governing body.
- 24.12.** Finishing position markets: Where the official finishing position is tied, for example four players sharing 10th place, the finishing position for settlement purposes will be 10th place.
- 24.13.** Top ten finish: Dead-heat rules apply.

## **25. Horse Racing**

### **General Horse Racing Rules**

- 25.1.** The advertised times of races, runners, riders and results as published, will govern settlement, obvious errors and omissions being allowed.
- 25.2.** Where multiple bets are concerned and the client has made it clear that only one meeting is intended, the bet will be settled for that meeting, even if other race times coincide, e.g. a Yankee 2.00 2.35 3.05 and 3.40. All times applicable to Newmarket, although there might be a 2.00 or 3.40 race at another meeting, the intention is clearly for all races at Newmarket.
- 25.3.** Where a meeting is given and a time, but no selection, the bet will be deemed void.

### **Double Engagements**

### **Forecasts Bets**

- 25.4.** Subject to the following rules, forecasts are accepted in singles, doubles and trebles only. Accumulators are not accepted.
- 25.5.** Forecasts are available in races of three or more runners and will be settled in accordance with the requested forecast dividend, for example computer, exacta etc.

- 25.6. Forecasts, inadvertently accepted in races with only two runners, will be settled as a win single on the selection nominated to finish first.
- 25.7. Should one runner finish alone, forecasts in which it is nominated as the winner are settled on the declared dividend unless none is given in which case forecasts will be settled as a single at SP or Pari-Mutuel price.
- 25.8. Where a forecast is selected and no forecast dividend is returned, bets will be settled in accordance with the N.S.L. starting price forecast chart.
- 25.9. If a forecast contains two selections that are in different races, then the bet will be settled as a win double.
- 25.10. If the forecast contains a non-runner, then the remaining selection will be settled as a win single at SP.
- 25.11. If a client asks for a forecast single and gives only one selection, it will be settled as a win single. If a reversed forecast is requested and only one selection is given, it will be settled as an each way single.
- 25.12. Instructions for a selection with the field or a selection against the field means, in both cases, that the selection is required to win. Instructions for the field with or the field against means, in both cases, that the selection is required to come second.
- 25.13. Unnamed favourites are not accepted in forecast betting.
- 25.14. Where a permutation is used, which could apply either to a forecast or a tricast and neither is specified, the bet will be settled on a forecast.

#### **Tricasts & Trios**

- 25.15. A tricast is a bet where selections must finish first, second and third in the correct order, in races where a computer dividend is declared. They are accepted as singles only.
- 25.16. Tricast bets accepted for races where no tricast dividend is declared will be settled as a forecast, with the third selection ignored.
- 25.17. Where the name and number of a selection has been given and they do not correspond, the name will take precedence for settling purposes.
- 25.18. Should a tricast contain a non-runner, the total stake will be invested on a straight forecast on the remaining selections in the order written. In the case of a full cover combination, the total stake will be divided equally as a reversed forecast on the remaining selections.
- 25.19. Should there be two non-runners, the tricast will be settled as a win single on the remaining selection. For the purposes of settling, a permutation is considered as a series of straight tricasts.

#### **Jockeys Mounts & Trainers Selection**

- 25.20. These are accepted on all our betting premises.

#### **Walkovers**

- 25.21. These count as races, but any horse so involved, will be treated as a non-runner.

#### **Postponements**

- 25.22. If a race is postponed to another day, with the exception of ante-post bets, all selections will be made void, unless announced otherwise for exceptional cases such as the Grand National. If races are set back in time because of weather conditions, the settling of all bets for the meeting will be governed by the original advertised race times.

### **Horse Racing**

#### **Place Terms**

- 25.23. The place terms of each way bets will be settled as follows based on the number of carded runner:

3 of fewer runners	Nil	
4-6 runners		2
7-13	3	
14 or more	4	

NOTE: Deductions due to scratchings will be applied according to the price of the relevant horse to win.

- 25.24. For bets other than ante-post, the number of placed runners, as determined in our place betting rules, will be governed by the number of carded runners for the race and not by the

number of runners that come under starters orders.

#### **Settlement of Bets**

**25.25.** In the event of no starting price being returned for horse race winners, then the last industry price given will be used for settlement purposes. In the event that no industry price was used then the Tote return will be used for settling purposes and vice-versa. If neither price is declared bets will be void.

Favourites & Numbered Selections

**25.26.** The favourite is the horse quoted at the shortest odds in the official starting price, the second favourite is the horse quoted at the next shortest price. If two horses are quoted at the shortest SP, then they will be joint first and second favourites.

**25.27.** Bets on first or second favourite are accepted win only at starting price. Each way bets on unnamed first or second favourites are not accepted and if taken in error, the place part will be settled as a win stake. Early prices or board prices cannot be taken on unnamed favourites.

**25.28.** If a client has backed an unnamed favourite and two or more co-favourites are returned, the stake will be divided equally among them and paid at full odds.

**25.29.** If a favourite is withdrawn, not under starters orders and no new market is formed, that favourite will be treated as a non-runner unless in placepots where your selection will revert to the next shortest priced selection, and the lowest race card number in the event of two or more equally priced selections.

**25.30.** In single bets, any un-timed favourite will be deemed to be for the next race due off, which is receiving full coverage, from the time the bet was placed. If a meeting is stated, but no time given, the bet will stand on the next race at that meeting.

#### **Withdrawals.**

**25.31.** When a horse is withdrawn, before coming under starters orders, or is deemed by the starter to have taken no part in the race, stakes will be refunded on that selection.

Board/Show/SP Prices

**25.32.** When a horse has been withdrawn then the remaining bets will be subject to deductions, incurring deductions according to the price of the non-runner at the time of withdrawal. However, should a new market be formed before the off of a race, then only bets with a price taken prior to the time of withdrawal will be affected.

Early Prices

**25.33.** The same applies for early prices with the exception that the value of the Deduction will be decided by the price of the withdrawn selection at the time that the bet was placed.

#### **Bets at Tote Prices**

**25.34.** We accept Tote win, each way, exacta forecasts and Tote placepots. We do not currently accept the Tote jackpot.

**25.35.** When a race meeting is not specified or cannot be identified, the bet will be taken for the principle meeting published in the Racing Post, unless the numbers stated do not fit the card for that meeting, in which case, it will be for the one or more meetings where the numbers do fit the card, with the stakes apportioned, if necessary.

**25.36.** Tote bets are not accepted on unnamed favourites

**25.37.** The maximum Tote return will be no greater than twice and no less than half of the equivalent SP return.

**25.38.** The maximum exacta forecast dividend will be no greater than twice and no less than half of the computer straight forecast.

#### **Restarted Races**

**25.39.** In the event of a false start etc. resulting in a race being re-run, under starters orders is negated and stakes will be refunded on horses not taking part in the re-run, with returns on the remaining runners subject to Deductions. The number of runners taking part in the re-run governs place terms.

#### **Information & Rules for Racing in Other Countries**

**25.40.** Bets are accepted for all races abroad where we advertise acceptance.

**25.41.** In races where an industry SP is made available, all bets will be settled at these prices, unless requested otherwise. In instances where no industry SP is made available, bets will be settled at Pari-Mutuel/Tote returns.

- 25.42.** Win & each way for foreign pools: Horses in the same ownership are generally coupled on the win pool only. In certain countries, e.g. USA and Belgium, horses are coupled for all pools. The place part of each way bets will be settled in accordance to the returned place dividends. Bets will be settled in accordance to the rules in place at each track.
- 25.43.** It must be noted that in the USA, two place pools are in operation, namely the place 1-2 pool for first and second only and the show 1-2-3 pool for first, second and third.
- 25.44.** It is your responsibility to specify which dividend you require when placing your each way bet. If no dividend is specified by you, then we will default your bet to the show 1-2-3 dividend. If no show dividend is declared by the race track, then your each way bet will be defaulted to the place 1-2 dividend. Any selections finishing third in this circumstance will be made losers. Coupled horses are treated as one runner for win, place and show dividends.
- 25.45.** Place only bets are not accepted and, if taken in error will be void.
- 25.46.** Forecasts: Straight and reverse forecasts, exactas and quinellas are accepted, depending on the type of forecast in operation. Should the instructions be for straight or reversed forecast/exacta and a quinella forecast is returned, then the total stake will be invested as a quinella forecast and vice-versa.

#### **First Past the Post/Official Result**

- 25.47.** We pay-out on both the first past the post result and the official result on all win and each way singles and multiples on horse racing in the UK and Ireland to a maximum payout advertised in the betting shop, subject to the following exceptions where we will pay the official result only:
- Ante-post bets.
  - Tote or Pari Mutual bets.
  - Forecasts and tricasts.
  - A void race.
  - A selection carrying the wrong weight or the jockey failing to weigh-in.
  - A selection taking the wrong course.
  - A selection given as a winner or placed, in error by the judge.
  - Incorrect transmission of a result.
  - An amended result given after the official result is declared, for example after successful appeal.
  - Any bets placed on favourite points, distances, without the Favourite or special match bet markets.
  - Two runner races.

## **26. Ice Hockey**

- 26.1.** Overtime counts on all markets unless otherwise stated on an individual event.
- 26.2.** Shoot-outs count for all markets including total goals. (Shoot-out winner is awarded one goal.)
- 26.3.** For the market total third period goals, the third period only will count. Overtime and shoot-outs will not be included.
- 26.4.** Where odds for both match and handicap betting are advertised, unless the handicap or a qualifying price has been requested, all bets will be settled on the match win. However, where only handicap betting is available, bets will be settled at the published handicap whether requested or not.
- 26.5.** The full 60 minutes play must be played for bets to have action.
- 26.6.** Periods must be played to completion for bets on period markets to stand.
- 26.7.** For player match up bets, all the quoted players must compete at some stage of the game for bets to have action.
- 26.8.** If the outcome of a two runner event is a tie, draw or exactly the number of quoted points and no price is offered for this outcome, then the result is a push. When this occurs, the settlement of single bets is to return stakes and for multiple bets the selection is treated as a non-runner and the bet will be settled on the remaining selections.
- 26.9.** Grand salami: This is a bet on the number of goals to be scored in a specified number of the days matches. For bets to have action, all games must complete in full, otherwise bets will be made void.
- 26.10.** Cup games: For outright betting only, shoot-outs count.

**26.11.** For future's betting, we may offer, divisional, conference and Stanley Cup outright markets, which will be advertised as such. It is the clients responsibility to be aware of which market they have placed a bet on.

## **27. Motor Racing**

### **General Motor Racing Rules**

- 27.1.** Outright team/driver championship betting: All in compete or not. Bets will be determined by the number of points accumulated immediately following the podium presentation of the final race of the season and will not be affected by subsequent enquiries.
- 27.2.** Individual race/meeting betting: All in compete or not. In the event of a disqualification, the podium presentation will count as the weigh-in and determine the settlement of bets. The start of any motor race is defined as the signal to start the warm up lap. Any driver on the grid at this time (inc. any starting from the pit lane) and failing to be classified as finished under the governing body rules will be deemed to be a runner and a non-finisher.
- 27.3.** Match bets: Bets are settled on the driver who finishes in the best position. Both drivers need not complete the race. If neither driver finishes, the one who has completed most laps will be the winner. Should both drivers retire having completed the same number of laps then all bets will be void.
- 27.4.** Qualifying match bets: Bets are settled on the driver who sets the quickest time in the qualifying session. Any time penalties or grid demotions given would not affect this result. If a driver takes no part in the qualifying session, bets on that match bet would be void. If a driver participates, but fails to set a time then he is deemed to be a runner and bets will stand.
- 27.5.** To qualify in pole position: All in compete or not. Bets settled on the driver who is announced as qualifying on pole immediately following the end of the qualifying session. Any subsequent demotion or disqualification would not affect the result.
- 27.6.** Fastest lap: Bets settled on the driver who is officially declared to have completed the fastest lap of the race.
- 27.7.** Podium/points finish: Bets settled on the drivers who finish the race in the podium/points positions, with the podium presentation counting as the weigh-in. Subsequent enquiries will not affect the result for settlement purposes.
- 27.8.** All bets will be settled on the official result. Go-Bet do not take any responsibility for positions which are obtained due to team orders.

### **Formula One**

- 27.9.** All results for Formula One bets are governed by the FIA's official classification at the time of the podium presentation.
- 27.10.** To be classified: In Grand Prix betting, FIA rules stipulate "Cars having covered less than 90% of the number of laps covered by the winner will not be classified". This is the criteria used to determine whether a driver is classified or not classified.
- 27.11.** If a driver completes 90% of the number of laps that the winner completed and his engine explodes forcing him to stop, he is classified under FIA rules and bets on that driver not to be classified will be losers. The official classification will be published in most daily newspapers the following morning or alternatively can be found on the website [www.fia.com](http://www.fia.com).
- 27.12.** Number of classified drivers: Bets settled on the number of drivers given an official classification by the FIA. See above for definition of this.

### **Speedway**

- 27.13.** Speedway handicap betting: Bets settled on the official result. In the event of an abandoned match all bets will be void, unless the running of the remainder of the match would not have affected the result.
- 27.14.** To win heat 13: Heat 13 is the scheduled race of riders one and five from both teams and is priced up accordingly. All four named riders must take part or all bets will be void.
- 27.15.** Speedway grand prix: All in compete or not. In the event of a disqualification, the podium presentation will count as the weigh-in and determine the settlement of bets.
- 27.16.** Speedway GP match bets: Bets are settled on the rider who scores the most points in the meeting. A price on the tie will be offered and in the event of a tie bets on either rider will be losers.

**27.17.** Heat betting: Team to score most points bets are settled on the team to score most points in that heat. Tactical bonus points do not count. A price on the tie will be offered, in the event of a tie, all bets on either team will be losers.

#### **Motorbike Racing**

**27.18.** Riders in place for the start of the warm up lap for race one are deemed as runners for race.

**27.19.** Any riders withdrawing from race two after race one will be deemed losers for settlement of race two.

### **28. Numbers Betting**

**28.1.** Bets are accepted up to the official starting time. If we are not satisfied that a bet has been placed prior to the start time it will stand for the next such event.

**28.2.** If for any reason any draw or event does not take place, bets will be cancelled.

**28.3.** Unless clearly specified, numbers bets will always be settled on the next such draw or event to take place. Where more than one draw or event is selected, bets will be settled on the next such consecutive draws or events to take place. If a specified draw has already taken place that day, then the bet will be settled on the next draw to take place.

### **29. Rugby**

**29.1.** Where odds for an outright tournament win, as well as 80 minutes play are displayed in Cup finals etc. unless to lift trophy, competition or a qualifying price has been laid, or requested, all bets are settled on 80 minutes play.

**29.2.** 80 minutes play will include any added injury or stoppage time, but not extra time. In the event of a match being abandoned before the final whistle, only bets that can be settled at the time of abandonment will stand. All other bets will be deemed void.

**29.3.** Where odds for both match win and handicap betting are advertised, unless the handicap or a qualifying price has been requested all bets will be settled on the match win. However, where only handicap betting is available bets will be settled at the published handicap whether requested or not.

**29.4.** Winning margin betting is from scratch.

**29.5.** Bets will be accepted up to the actual kick off time. If a bet is inadvertently accepted which includes a match after its kick off time, the match will be treated as a non-runner. In first try scorer bets, penalty tries do not count. Every effort is made to quote all players for a team, however, if the first/last try is scored by a player not quoted in the original list, that player will still count as the winner.

**29.6.** Anytime try scorers: This bet involves predicting whether a particular player will score a try at anytime during a match. Bets will stand until the final whistle and not include any extra time played. If for any reason a match is abandoned before the final whistle, stakes will be refunded irrespective of whether the nominated player has scored or not. Multiple bets are accepted.

**29.7.** All speciality bets have individual rules, which will be displayed on the internet.

**29.8.** Divisional & title betting: The finishing position of teams at the end of the scheduled season will determine places, this includes points deductions the league may apply before the end of the season. End of season play-offs and penalties incurred by clubs after the end of the season will not count.

### **30. Skiing**

**30.1.** Outright betting: All in compete or not.

**30.2.** Should an event be postponed, bets will stand only if the event takes place at the same venue within a seven day period, otherwise bets will be made void.

**30.3.** However, in the case of World Championship and Olympics, bets will stand on that particular discipline irrespective of whether the time and date of the event are rescheduled. If the event is abandoned and does not take place, bets will be made void.

**30.4.** For outright markets dead-heat rules may apply.

**30.5.** Bets are settled on the official results as published by the International Ski Federation. However, in the event of a disqualification, the podium presentation will count as the weigh-in and determine the settlement of bets.

**30.6.** If a meeting has two identical races taking place on separate days and the first race is cancelled, then bets struck on the first event will be settled on the results of the second race.

**30.7.** In head to head betting, both competitors must start or bets will be made void. Should a competitor start and withdraw, bets struck on this competitor will be deemed losers.

### **31. Snooker & Pool**

**31.1.** Outright betting: All in compete or not.

**31.2.** Match betting: In the event of the match being awarded to a player before the full number of frames/racks has been played, match bets will stand on the official winner, provided at least one frame/rack has been played. If one frame/rack has not been completed, all match bets will be void.

**31.3.** Frame/rack/speciality & handicap betting: The full number of frames/racks required to win the match must be achieved. In matches, where, for any reason whatsoever, the match is awarded to a player before this is achieved, then all frame/rack betting and handicap betting on that match will be void, unless further play could not affect the result.

**31.4.** Highest break score/player with highest break: In the event of a match being awarded to a player before the full number of frames required to win has been played, then highest break specials will be made void, unless further play could not affect the result.

### **32. Speciality Markets**

**32.1.** We will cover a wide variety of special events ranging from Christmas specials to entertainment, political, and other non-sporting events.

### **33. Tennis**

**33.1.** Outright betting: All in compete or not.

**33.2.** Match betting: The full number of sets required to win the match must be completed in order for match bets to stand. If for whatever reason the full number of sets required to win the match are not played, then match bets will be made void.

**33.3.** Set betting: A player must win the full number of sets required to win the match. In matches where, for any reason whatsoever, the match is awarded to a player before this is attained, all set betting on that match will be made void unless further play could not affect the result.

**33.4.** Total games in set market: The full number of games required to win the set must be achieved. In sets where for any reason whatsoever, the set is awarded to a player before this is attained, all total games betting on that set will be made void unless further play could not affect the result.

**33.5.** Total games in match market: The full number of games required to win the match must be achieved. In matches where for any reason whatsoever, the match is awarded to a player before this is attained, all total games betting on that match will be made void unless further play could not affect the result.

**33.6.** In the event of countries competing in a tournament, should the players listed as the participants competing change, match bets will be void. We will endeavour to form a new market on the new competitors.

**33.7.** In the event of any of the following circumstances all bets will stand:

- a. A change of venue.
- b. A change from indoor to outdoor court or vice versa.
- c. A change of playing surface.
